Contact with Us

Cookies

Our website uses, so-called cookies. These are small text files which are stored on your mobile device using the browser. They're not doing any damage. We use cookies to make our website user-friendly. Some cookies remain stored on your device until you delete them. They enable us to recognize your browser the next time you visit us.

If you do not wish this, there is the possibility to set the browser that it informs you about the setting of cookies and you are able to only allow this in individual cases. When cookies are deactivated, the functionality of our website may be limited.

Web Analysis

Our website uses functions of the web analysis service Google Analytics (*Google LLC, 1600 Amphitheatre Parkway, Mountain View, CA 94043, USA*). Cookies are used for this purpose, which enable an analysis of the use of the website by your users. The information generated in this way is transferred to the provider's server and stored there. You can prevent this by setting your browser that no cookies will be stored.

We have concluded a corresponding contract with the provider for order data processing.
